This month we will be having two combined MOAA & MOWW Luncheon meetings: first, the <u>PEACE OFFICERS MEMORIAL DAY Celebration</u>, at Noon on <u>Wednesday</u>, May 15th at 11:30 AM at the San Luis obispo <u>Elks Club</u>, and the second, is on <u>Saturday</u>, May 25th, at 11:00 AM, for our Annual Atascadero Lake Park MOAA & MOWW Picnic.

As explained by Ron Janney, the Peace Officers Memorial Day was created in May of 1961 by Congress and was signed into law by President John F. Kennedy on October 1, 1962. May 15 was designated as the day to honor and pay tribute to local, state, and Federal peace officers who have died in the line of duty. The week during which May 15 falls is designated as Police Week. On May 15, flags should be flown at half-staff to honor the fallen officers of our Nation. There are 34 fallen officers nationwide in 2019 as of this writing.

During Police Week, there are Ceremonies in Washington, DC; Sacramento, and here locally. The Ceremony at the Nation's Capital attracts from 25,000 to 40,000 officers and their families. The Ceremonies include the Blue Mass, Candlelight Vigil, Wreath Laying Ceremony, National Police Survivors' Conference, Honor Guard Competitions, and

the Emerald Society Pipe Band March and Ceremony.

To honor our local Law Enforcement Officers, we selected the Officer of the Year from all agencies in the County and will be presenting a Certificate of Appreciation at the May 15th meeting. This year MOWW reached out to honor a federal law enforcement officer and have selected Special Agent Marni Barton from the Federal Bureau of Investigation.

EARLY PHYSICAL THERAPY FOR NECK PAIN SAVES MONEY, LOWERS OPOID USE

A study that focused solely on neck pain found that over a year's time patients who waited more than 90 days to see a PT after initial health care consultation for neck pain were 2.79 times more likely to receive an opoid prescription than were patients who met with a PT within 14 days of the index visit. At the end of 1 year, the average adjusted total health care cost for the "early physical therapy "group was \$1,853-less than half the \$4,026 cost associated with the "late physical therapy" group.
